

From the President...

Thank you Sheila Wyman, Nan Brittain, Dave Howard and Wayne Weidmann for being a big part of the very dependable group that mans the timing trailer. The entire club backs our Governor and the competition program, so a big thanks to all of you!

And, you might actually enjoy the journey and have some fun along the way. Treasurer's Report: Nan Brittain gave a Charity Fund report and explained the payments made for CCI's upcoming Ankeny autocross (total cost of \$800). CD's will come due in May/June (Nan will handle at that time and confirm back to the Board). No detailed Treasurer's Report was given during this meeting.

Vice President's Report: Kris Howard gave details on Saturday, April 27th cruise to Templeton Rye and then to Darrell's Place in Hamlin, IA. See details and a flyer in *Sportsmate*. August 20th general meeting booked with Albaugh (CCI Members only). August, 2019 – Vettes on the River (more info to follow in Sportsmate & during meetings). Governor's Report: Sheila Wyman said the West Region Banquet is this Saturday, April 6th. Motion from Sheila that CCI pick up

the gratuity for the banquet, seconded by Nan and passed. Memorial Day Weekend will be our Ankeny autocross event (flyer to be posted in Sportsmate). Chariton, Iowa event slated for June, 2019 (more info to follow in upcoming meetings). Some concern at this date as to will CCI have sufficient number of sanctions to hold these events. We may know by April 17th.

Competition & Social Media Director's Report: Nichole Parnell had no report at this date (will have an update at our April general meeting). Member at Large Report: Steve Howard had no report. Editor's Report: Dave Howard said he needs event pictures from previous CCI events & Webmaster's Report: cruises, etc. Weidmann received a request from a Terry Breen of which no Board member was familiar with. Point Director Report: Wayne Nikolish had no report. Membership Director's Report: Hommer said CCI currently has 124 club members. General meeting at Smokey D's BBQ was called to order @ 6:45PM by President Linda Hommer. Linda asked if we had any new members or guests at the meeting but there were none. Secretary's Report: Dave Howard substituted for Judi Nikolish in her absence and said minutes of the abbreviated March meeting are posted in Paul Wyman made a motion to Sportsmate. approve the minutes as posted, seconded by Jim Lucas and passed. Treasurer's Report: Brittain remarked that some sponsor income was received during the month but not much other activity to report. Motion to approve Nan's report was made by Jim Lucas, seconded by Paul Wyman and passed.

Vice-President/Social Director's Report: Howard went through our upcoming social activities which include a cruise to Templeton, IA on Saturday, April 27th for a tour of the Templeton Rye Distillery, then go for dinner a little way south in Hamlin, IA. There is also a roll-in event at DMACC on May 3rd being put on by their Auto Collision program. Flyers for these two activities are in Sportsmate. Kris reiterated that our August club meeting will be held at Albaugh's headquarters in Ankeny. Also in August will be a road trip to Vettes on the River in LeClaire, IA on the 23rd & 24th (look for more on that in Sportsmate). Lastly, Kris said KSH Design will soon be offering embroidery capabilities for various club apparel. Governor's Report: Sheila Wyman said the West Region Banquet at Echo Valley Country Club on April 6th was a great success. Our Ankeny weekend over the Memorial Day holiday is a little over a month away and we will need lots of workers. Sheila also said the next WR & NCCC meetings are May 3rd & 4th.

Competition Director's Report: Nichole Parnell indicated that Sheila had covered everything about our Ankeny event. With help from Jay Hommer, Nichole handed out awards (including a few "Bob Awards") to club members who missed out on the West Region or CCI banquets. Editor Dave Howard reminded the group to look for the complete By-laws revisions in the May Sportsmate. Points Director Wayne Nikolish wasn't present and there was no report. Membership Director Jay Hommer reported that we now stand at 124 total members. Webmaster Wayne Weidmann said he is still looking for sponsorships for the St. Jude's cruise. Member at Large: Steve Howard reported \$60 would go to the winner of the 50/50 drawing... winner was Dave Larson. Steve had nothing additional to report. President Linda Hommer reported that different versions of the so-called "front plate bill" have resurrected in this year's legislature. Not much certainty about what, if anything will come of this. Linda also stressed again that officer nominations and position descriptions will get a lot of attention over the next several months.

Old Business: there was discussion after a question about the flooding situation at RPM near Pacific Junction and the effect it could have on CCI & Cornhuskers holding a joint event there. Still considerable uncertainty surrounding this. Pat Whalen also mentioned donations for the St. Jude's trip. New Business: after discussion of the changes to By-laws and Supplemental Rules, the position title of Information Dissemination Director (proposed to perform the combined duties of Webmaster and Social Media Director) should simply be called Social Media Director. Gary Foster then moved to put all the changes to a vote at the May general meeting, Denny Luther seconded and the motion passed. Mike Golightly talked about providing volunteers for Good Guys, Schaefer's Lubricants and passed around a flyer for the Chili King cruise night. Buy & Sell: Tom Treska is looking for 1966 Iowa license plates – needs 16 counties to complete his collection. Sheri Jandik has a Jeep cargo cover.

A motion to adjourn was made by Nichole Parnell, seconded by Kris Howard. Meeting adjourned @ 7:40PM.



PROPOSED BY-LAW CHANGES FOR 2019

Current By-Law

ARTICLE 4, SECTION 2: The appointed board members of this club shall be: Editor, Competition Director, Points Director, Webmaster, Membership Director, and Social Media Director. Appointed board members are encouraged to attend monthly Board meetings.

Proposed Change

ARTICLE 4, SECTION 2: The appointed board members of this club shall be: Editor, Competition Director, Points Director, Membership Director, and Social Media Director. Appointed board members are encouraged to attend monthly Board meetings. Webmaster was eliminated and Social Media Director position title was retained.

Current By-Law

ARTICLE 4, SECTION 5, B: The duties of the <u>Vice-President</u> are to preside in the absence of the President, and to supervise the club's social activities, Editor, Webmaster and Social Media Director. Also, social events where points will be awarded will be presented to the CCI Board for approval. The Vice President is responsible for appointing members to the Officer Nomination Committee, Awards Banquet Committee and Treasury Audit Committee.

Proposed Change

ARTICLE 4, SECTION 5, B: The duties of the <u>Vice-President</u> are to preside in the absence of the President, and to supervise the club's social activities, Editor and Social Media Director. Also, social events where points will be awarded will be presented to the CCI Board for approval. The Vice-President is responsible for appointing members to the Treasury Audit Committee.

Current By-Law

ARTICLE 4, SECTION 5, C: The duties of the Secretary are to take minutes at the meetings and retain all important documents. The Secretary is also responsible for the supervision and coordination of the activities of the Rules and Bylaws Review Committee, Balloting Committee and CCI's Corporate Agent. The Secretary is also responsible for the maintenance of CCI's Articles of Incorporation, bi-annual report receipt from the Iowa Secretary of State and current CCI By-Laws and Supplemental Rules.

Proposed Change

ARTICLE 4, SECTION 5, C: The duties of the <u>Secretary</u> are to take minutes at the meetings and retain all important documents. The Secretary is also responsible for the supervision and coordination of the activities of the Rules and By-Laws Review Committee, Balloting Committee, Officer Nomination Committee and CCI's Corporate Agent. The Secretary is also responsible for the maintenance of CCI's Articles of Incorporation, bi-annual report receipt from the Iowa Secretary of State and current CCI By-Laws and Supplemental Rules.

Current By-Law

Article 4, Section 5, D: The duties of the <u>Treasurer</u> are to be responsible for all monies, bills received, all property owned for resale and all property not for resale. The Treasurer supervises the Dues Review Committee and will oversee the distribution of dues renewal notices. The Treasurer is also responsible for supervising the activities of the Property Inventory Committee and the Advertiser Fee Structure Review Committee. The Treasurer is responsible for maintaining a permanent record of all financial records, club check book, property inventory listing, tax filing, annual insurance and license on competition trailer.

Article 4, Section 5, D: The duties of the <u>Treasurer</u> are to be responsible for all monies, bills received, all property owned for resale and all property not for resale. The Treasurer supervises the Dues Review Committee and will oversee the distribution of dues renewal notices. The Treasurer is also responsible for supervising the activities of the Property Inventory Committee and the Advertiser Fee Structure Review Committee. The Treasurer is responsible for maintaining a permanent record of all financial records, club check book, property inventory listing, and annual insurance and license on competition trailer. The Treasurer or his/her designee is also responsible for all tax filings of the club. Tax filings for the club are completed on a calendar year basis.

Current By-Law

Article 4, Section 5, E: The duties of the <u>Governor</u> are to report NCCC activities, to attend NCCC meetings, to collect NCCC dues and to issue NCCC membership materials. The Governor shall also be responsible for supervising and coordinating the activities of the Points Audit Committee, Points Audit Director, Competition Director, Competition Committee and Membership Director.

Proposed Change

Article 4, Section 5, E: The duties of the <u>Governor</u> are to report NCCC activities, to attend NCCC meetings, to collect NCCC dues and to issue NCCC membership materials. The Governor shall also be responsible for supervising and coordinating the activities of the Points Audit Committee, Points Audit Director, Competition Director, Competition Committee, Awards Banquet Committee and Membership Director.

Current By-Law

Article 4, Section 5, I: The duties of the Member at Large are to represent the interests of the membership at board meetings. Specifically, the Member at Large is to act as a liaison or means for members to present issues to the board. The Member at Large is also responsible for promoting club goodwill (sympathy cards, wedding cards, etc.) and other duties as assigned to them by the President. The Member at Large is a member of the Officer Nominating Committee and the Dues Review Committee.

Proposed Change

Article 4, Section 5, I: The duties of the <u>Member at Large</u> are to represent the interests of the membership at Board meetings. Specifically, the Member at Large is to act as a liaison or means for members to present issues to the Board. The Member at Large is also responsible for promoting club goodwill and other duties as assigned to them by the President. The Member at Large is responsible for securing meeting sites for all Board and General membership meetings. This officer is also responsible for conducting the 50/50 drawings and ensuring the Treasurer receives 50% of the drawing proceeds for deposit in the Charity Fund. The Member at Large is a member of the Officer Nominating Committee, Awards Banquet Committee and the Dues Review Committee.

Current By-Law

Article 4, Section 5, J and L: The primary duty of the <u>Webmaster</u> is to keep the website current. At the discretion of the Webmaster, he/she may ask for assistance with keeping the website current. The Webmaster is accountable to the Vice President.

The primary duty of the Social Media Director is to administer CCI's social media sites, including but not limited to, posting current events, such as club activities, event pictures, etc. The Social Media Director is accountable to the Vice President.

Article 4, Section 5, K: The primary duty of the <u>Social Media Director</u> is to administer CCI's social media sites and be the primary point of contact for the website administrator. This person is also responsible for updating CCI's calendar on the website and the dissemination of club email notices. The Social Media Director is accountable to the Vice-President.

Current By-Law

Article 4, Section 5, K: The duties of the Membership Director are to promote activities which retain current members, recruit qualified new members and act as a liaison for new members and guests at club functions. Additionally, the Membership Director is responsible for maintaining blank membership applications, providing welcome notebooks for new members and the publishing and maintenance of the club's membership roster. The membership roster will be posted to the CCI website in the Members Only page quarterly and a new member listing published monthly in the *Sportsmate*. The Membership Director is accountable to the Governor.

Proposed Change

Article 4, Section 5, J: The duties of the Membership Director are to promote activities which retain current members, recruit qualified new members and act as a liaison for new members and guests at club functions. 
